Priority Health is proud to partner with CenteringPregnancy providers at CHI accredited Michigan Centering Sites in Regions 4 and 8. These sites include Spectrum Health OB/GYN Residency Practice in Kent County, Hackley Community Care Center in Muskegon County, Grace Health in Calhoun County and InterCare Community Health Network in Berrien County.

Centering, an evidence-based model of group healthcare, combines a health assessment with interactive learning and community building to help support positive health behaviors, drive better health outcomes, and address the complex social determinants of health. CenteringPregnancy brings pregnant women who are due around the same time, together for routine prenatal care. Studies show CenteringPregnancy lowers the risk of preterm birth, closes the disparity gap in preterm birth between Black and white women, increases breastfeeding rates, and improves both visit adherence and patient satisfaction.

"Supporting a care model that not only improves health outcomes for members but also lowers overall health costs is a win-win. We are proud to offer this new incentive to providers who transition to the CenteringPregnancy care model," said Marti Lolli, Chief Marketing Officer and Senior Vice President Consumer and Government Markets at Priority Health. "We look forward to continuing our partnership with the Centering Healthcare Institute to help address racial health disparities within prenatal care here in Michigan."

When compared to traditional care, studies show CenteringPregnancy lowers the risk of preterm birth by approximately 33%. In addition, Michigan Centering sites have also seen reduction in the disparity gap in preterm birth rates between Black and white women, increases in breastfeeding rates, and improved visit adherence & patient satisfaction.

By incentivizing Centering visits, Priority Health is recognizing the investment required by providers to transform care delivery from an individual to a group care model. The Centering Healthcare Institute's team lauded Priority Health for launching the new incentives.
